MTCA TRYOUT / PLAYING TIME / ENROLLMENT POLICY:

For grades 5-6, the MTCA has a no-cut policy. Tryouts may be held to determine skill level. If enrollment dictates, tryouts may be held to distribute talent among multiple teams. Each athlete will participate in the equivalent of at least one quarter per game / match. Registration is accepted on a first come, first serve basis (defined as receipt of forms and fees). For grades 7-8, the MTCA has a tryout policy. Tryouts will be held to determine a player's skill level and to determine team composition. In general, teams will be limited to 13 players. Each athlete will participate in a cumulative amount of playing time equal to approximately one game / match per season. Please refer to MTCA policies for additional information.

VOLUNTEER COMMITMENT:

MTCA requires participation by all parents to help make our programs successful. Every family is required to pay the registration fee upfront with a \$50 deposit towards their concessions volunteer requirement. Each family is required to volunteer for 4-5 hours of concession duty. If volunteer hours are fulfilled, the \$50 deposit will be returned to the family. This requirement does go toward the school volunteer requirement.
